THE MAYOR SUGGESTED THAT THE CITY NOT COMMIT TO PROVIDING ANY YEARLY ASSISTANCE TO THE COUNTY FIRE DEPT. AT THIS TIME, IF THE COUNTY REQUESTS, THE CITY WILL CONSIDER REVISTING THIS ITEM OF BUSINESS IN THE 2026-2027 BUDGET. THE COUNCIL AGREED WITH THE MAYOR.
